



Below is an artist's impression of how the resort might look, including the covered greens.
















#### **NOW DOWN TO THE BUSINESS END!**

#### **REMINDERS**

Memberships are due for renewal. Please make sure you are financial before taking part in any Club or State Championships.

If you intend to play your championship game prior to the scheduled date/time, you must complete the Match Variation Form and submit it to the Match Committee. Once the change has been approved, the Match Committee will update the draw in the space provided.

The attire for all Club Championships is the current pennant uniform. Allowances will only be made if we are low in stock and cannot provide a uniform.

#### **MAJOR MINOR PAIRS**

During the Major Minor Pairs, I received a written concern from a member regarding the substitution rules in club Championships. This concern has been brought to the attention of the Match Committee, Management and Board of Directors. The Match Committee has discussed the matter and a response is forthcoming, once the Board Meeting has taken place. As a courtesy, a written response will be





forwarded to our member and then any outcomes that relate to changes to our Club COP will be published in a subsequent Newsletter.

Below is the State COP regarding appeals.

#### 1.29. Appeals and Disputes

Disputes or appeals arising out of the application of these Conditions of Play should be resolved by the relevant Controlling Body.

A decision taken by a Controlling Body shall be binding in all respects if any immediate result is required.

An appeal may be made to the next highest authority:

- to Club, then
- to Region, then
- to the State Match Committee, then
- to Bowls NSW Board/Appeals Tribunal. Any appeals to Bowls NSW Board must be in accordance with the Bowls NSW Appeals Policy. Appeals must be accompanied by all relevant information.

A reminder to our members that if you do have a concern over the management of our Bowls Section, please forward the concern in writing to myself, our Bowls Organiser, or a member of the Match Committee. This will then be forwarded to our Management and Board if required. Matters arising prior to, during, or after a game will be dealt with by the Controlling Body on the day.

What has become apparent is a minority of our members are not happy with the direction that our club is taking with regards to the management of our bowls section. This is obvious by the recent influx of opinions that have been expressed lately.

In our <u>May Newsletter</u> there were several items that summarised some of the changes that our Match Committee have implemented for the 2024-2025 Season. Please take the time to go through them.

Opinions that have been expressed so far relate to Double Headers, & Open Triples / Fours. I believe there have been some written concerns forwarded to management, but I'm not aware of the contents yet as nothing came through the Match Committee. (Hint #1)





#### **DOUBLE HEADERS**

We have the dates, including scheduled start times on each entry sheet. These dates are also included in the yearly program on the noticeboard, and on our website. The Match Committee will utilise am and pm games where it sees fit. With regards to the recent Major Pairs draws. Several weeks before the entries closed, we were approached by some of our male and female members. They were involved in the Decky Robinson Indigenous Weekend, which clashed with our pairs that were scheduled early in July. This was overlooked by the Match Committee during programming of our schedule. Rather than disadvantage any players, it was easier for the Match Committee to remove that weekend from our Championship calendar and run the pairs over the remaining two days in the calendar, with the final played at a later date. We're also aware that several players will be involved in either a State or Regional event at the same time as our Major Pairs. These players will get dispensation and the games can be rescheduled to an appropriate date. Players are free to utilise the spare days leading up to the competition to complete their first round game to avoid a double header.

Running the competition this way gets us down to the finalists for both the Men's & Women's events. The finals for the Major Pairs must be completed prior to the closing date for the Champion of Champion Men's and Women's Pairs. This is in March next year. The Major Singles and Pairs come under the State COP as below.

#### 2.5. Dates of Play

Clubs must conduct their 2024/2025 Singles and Pairs Championships after 1 July 2024 and concluding before the closure of Champion Club Champions Singles and Pairs.

The Major Singles and Major Pairs provides a pathway for both men and women to continue on to State, National and even World Champion of Champions. All these events are double headers, with 3 games scheduled on one day in the singles. If you intend to win our Major Singles and Pairs, you'll be eligible for the Champion of Champions. Please ensure you can manage playing two to three games in a day for the Champion of Champions.

We have both Men's & Women's Major Singles and Major Pairs scheduled in our program. This is to give our players the best opportunity to be eligible for the Champion of Champions and represent our club at the next level and possibly beyond. Unfortunately, last season the Bowls NSW State Women's Champion of Champions was not entered by either of our winners from Windang.

If there is no support for the State Champion of Champions, there is no reason to have single gender singles and pairs competitions. (Hint #2)

Our players are well accustomed to double headers as they play in Tournaments, Carnivals, Gala Days, District Championships, District Champion of Champions Singles, Zone Championships, Regional Championships, State Carnivals, Women's State Pennants Finals, Men's State Pennant Finals, Open Gender State Pennant Finals, State Interzones Championships, Men's





Inter-Regional Sides Championships, Women's Inter-Regional Sides Championships, State Mixed Pairs Championships, State Over 40's Pairs Championships, State Rookies Championships, Australian Indoor Championships, BPL Cup Events, Australian Open Championships which are all double headers, and in some cases more.

Our Major Pairs competition has more entries than last season so it appears to be well supported. Our Major Singles has an unprecedented number of entries so it looks like our rounds may have to be split to accommodate the number of matches as we don't have enough rinks even with the 3 greens in play.

When a player enters any of our competitions they agree to the T's & C's of the competition. In our case these are the <u>State COP</u> and any guidelines or conditions that the club has in place at the time.

The bottom line is - If you don't agree with the T's & C's.....it's not that complicated, don't enter the event in the first place! (Hint #3)

#### **OPEN TRIPLES & FOURS**

As a Match Committee we pride ourselves in the way we manage bowls at Windang, and we always endeavour to align our principles with that of BA and Bowls NSW, creating an environment that supports diversity, equity and inclusivity. When we have to manage both men's and women's events at club level, it's always wise to refer to the principles outlined in the Bowls Australia

Open Bowls Position Statement

The following statement from the Bowls NSW COP refers to Triples & Fours.

#### 2.4. Triples & Fours

Clubs may determine their own Conditions of Play to conduct Triples & Fours Championships.

Any Conditions put in place for Club Triples and Fours should be aimed at maximising participation in these events and must be clearly displayed on the entry form for these events.

In the 2022-2023 Season, all of our Championships were classed as Open events. Each discipline was split into Major and Minor categories. This was well supported and was very popular with our members. The table below shows the figures.

We did not receive any written concerns about these open events. Quite possibly due to the fact that both clubs were still separate entities at the time and the women's club still had "women only" events available, and players were eligible to play in either event. During this season, "men only" events were not available. We had no written concerns regarding this fact either.

In the 2023-2024 season, our club was in the back end of our unification process. Our Women's Club had already formed their bowls program for the season, this included Women's Singles, Pairs, Triples & Fours. As a unified club, we had no option but to go back to Men's Singles, Pairs, Triples & Fours, as continuing with the Major and Minor disciplines would have created too many competitions to run viably. A lot of our players were disappointed as they enjoyed the concept of open major and minor events. It created an even playing field and gave them an opportunity to win a team event that was relative to their playing ability.

In the 2023-2024 season we had a total of 22 teams (88 players) entered into our Fours competitions. The Fours were split into single gender events with 9 teams in the women's event and 13 teams in the men's event.

The Triples Competitions had a total of 26 teams (78 players) entered. The Triples were also split into single gender events. 10 teams in the Women's Triples and 16 teams in the Men's Triples.

Since the unification of our Men's and Women's Bowling Clubs, our Prize Money for Club Championships is now based on a 3 tier scale, reliant on the number of entries, not the number of players.

In none of these cases above did we reach the top tier prize category.

Bet you didn't know that!...... You'll know when you open up your prize money envelope! (Hint #4)

The women's events just scraped into tier 2, and the men's events were at the higher level of tier 2. It was obvious that combining both the triples and fours would help maximise the participation numbers. This in turn provides for a better competition, rather than making it into the Q/F's without playing a bowl. The prize money available would then reach the top tier.





Our Social Bowls, for any day are open gender and there is no problem with any particular gender winning the game and/or the prize money. (These days it's more about who gets the loudest boo's when they're drawn out as winners - Gopher comes to mind here). Our Open Gender Pennants are the same. Regardless of what gender you are, it's always a great feeling to get a win with your teammates, or at the end of the game to get together with your opposition. The best feeling is to be holding a flag that you've earned for your club and with your teammates, and then head off to the State Finals. In the State Reserve Championships, it doesn't matter what gender you are. It's an absolute buzz to be holding that medallion in your hands after you've played your heart out for your club, your teammates and now your region.

If we chose to have a single gender Women's Competition in Triples and Fours, we'd be obligated to provide an opportunity for Men's Triples and Fours, and possibly Open Triples and Fours to take place. This principle has been applied to our Men's and Women's Major Singles and Pairs, coupled with the Open Minor Singles and Pairs. As well as an Open Singles event. This is plainly stated in the BA Statement.

Where only single gender competition is offered, it is desirable to provide an opportunity for Open Bowls to take place;

Wherever possible, promote and encourage Open Bowls at grassroots level;

With all these events in place, could you imagine how many double headers would be involved then. To manage all these events would quite possibly require a combination of sectional play and knockout, similar to the State Championship models, and attempting to free up space somewhere.

This could easily be achieved by Windang not supporting the Single Gender Pennants at all and concentrating on the Open Pennants only. This would give us the space required (Yes... that's Hint#5)

One thing that makes me laugh is when members tell us we should avoid scheduling events at a particular time of year as they've booked their holidays at that time. I suggest you provide your itinerary to Bowls NSW so they can let us know when to schedule our Championships around you.

Still feel like you can do a better job? I know you can, because you tell us nearly every day how wrong we are doing things. It's time to walk that talk. You are more than welcome to nominate for the Match Committee and Selection Committee positions at the next elections.

I thank our Match Committee volunteers for their commitment and diligence as it was quite challenging to form a program out of an already congested calendar. I commend them on their decisions that will ensure our club, and our sport, continues to grow well into the future.
